5 PRESENTATIONS AND VERBAL UPDATES

5.1 Actions update from 25 July CDEM Group meeting

Completed actions:

 Emergency Management Bill Submission - Manager Emergency Management, Joe Kennedy confirmed that this had been actioned and met the deadline date.

Discussion was held around the CDEM increase in levies. Tasman district Council – Chief Executive, Janine Dowding, summarised the breakdown of increases and noted that remuneration was a 10% increase and that this would still be the fourth lowest regional salary budget and the third lowest staffing numbers (across 16 CDEM Groups).

Nelson City Council Deputy Mayor, Rohan O'Neil-Stevens joined the meeting at 1.37pm.

Action: Joe Kennedy to follow up with Nelson City Council to provide a Civil Defence

Emergency Management (CDEM) presentation regarding the increase in levies for

the Long Term Plan.

5.2 Update from the National Emergency Management Agency (NEMA)

Regional Emergency Management Advisor, Oli Varley gave a verbal update and tabled a document, which is available on Council's website in the Minutes Attachment Document.

Mr Varley answered questions regarding role changes in the NEMA Leadership Team, reinstatement of the Emergency Management Bill, upcoming exercises, after action review from the Auckland weather event and noted that the Government enquiry into the event was due with the Minister by 7 December 2023.

Action: Nelson City Council and Tasman District Council to submit a supplementary

submission to the Emergency Management Bill proposing a mechanism by both Council's to be able to condense a Special Consultative Procedure and Long Term Plan process as part of the recovery of a declared civil defence emergency.

Action: Joe Kennedy to provide legislation information regarding the Emergency

Management Bill.
