3 PUBLIC FORUM

Julie Baxendine (Director of Nelson Cricket), George Vance (General Manager of Nelson Cricket) and Jack Sutherland (Life Member of Nelson Cricket), provided an update to the Committee on the the presentation made by Tim Murdoch (Former Operations Manager of Nelson Cricket) on 3 August 2022, where he discussed the lack of international cricket at Saxton Field due to the lack of infrastructure. They also provided a report on the 2022/2023 fixtures and the posibility of future fixtures at Saxton Oval and the infrastructure requirements to host national and international games.

Questions and discussions included:

- The need for fibre to the wicket and media towers and the cost for these
- The proposed difficulty with fundraising for the media towers and that help would be needed from the Council
- Fibre was currently installed to the greenkeepers building and conduit that goes to the wicket.
- What other components would be needed to gain international matches if the fibre to the wicket and media towers were in place? - training facilities, scheduling and accommodation.
- How were bids tendered?
- Could they get away with having scaffolding for games for next summer to confirm having international games
- Will Nelson Cricket look at getting lighting on the oval for night games?

Douglas Jackson (Skate Nelson) discussed building a skate park at Saxton Field in the area of Circus Green. Mr Jackson noted how Skate Nelson started with the help of the Lions and fundraising and that cost of the skate park would be around \$2m. He confirmed that all members of the Skate Nelson Board were skateboarders but that would be consultation with professionals on the design of the skate park.
